OHSC Membership Dues Form Information Sheet

- OHSC By-laws:** Hard copies of the OHSC by-laws are kept at the front desk during normal business hours during the pool season. They can be found online on our website at: <http://www.orangehunswimclub.org/aboutus/bylaws.html>.
- Early Bird Special:** Mailed forms with payment postmarked on or before April 6 of the current season receive the discounted *Early Bird* pricing.
- Preseason Sale:** Preseason purchases may be picked up at the front desk during normal business hours. Sale ends May 31 of the current season.
- Guest Passes:** Guest Passes can be purchased directly from the front desk during normal business hours during the pool season.
10-ct Guest Pass Card: \$30 (expires 9/15/2019)
20-ct Guest Pass Card: \$60 (expires 9/15/2020)
- Concession Cash:** Concession cash can be purchased at the Shark Shack during regular Shark Shack business hours; not sold during meets or special events.
- Membership Cards:** Membership cards are valid for the duration of membership. All new members four (4) years of age or older, as of January 1 of the current year, are issued a membership ID card and will need to submit a headshot for check-in purposes. Lost cards may be reprinted for a \$5 fee. For complete information go to: <http://www.orangehunswimclub.org/memberresponsibilites/membershipcards.html>
- Senior Double:** *New category in 2019.* Members applying for the Senior Double category must both be at least 65 years of age. Only two (2) persons may be on the membership. *Age verification may be requested.*
- Senior Single:** *New category in 2019.* Members applying for the Senior Single category must be at least 65 years of age. *Age verification may be requested.*
- Senior Lottery:** The Senior Lottery allows for the opportunity to possibly have only your annual dues paid from your Capital Improvement Fund (CIF) bond. This does not include payment of optional merchandise (i.e., guest passes) or childcare fees. Lottery will take place 10 business days after April 6. Up to 10 slots will be awarded. All participants will be notified within 5 business days of the drawing. Winners will have their annual dues payment refunded and have a commensurate amount deducted from their CIF bond.
- Senior Lottery Eligibility Requirements:**
- Must be a current permanent member eligible for either the Senior Double or Senior Single membership category.
 - Must have been a Permanent member for at least one (1) year.
 - Member must have paid the CIF bond, not the Initiation Fee.
 - Completed membership form and dues must be postmarked no later than April 6 of the current lottery year.
